NMSE Digital Asset Licensing – Terms & Conditions

- 1. National Museums Scotland agree to grant a non-exclusive Licence to the Client:
 - a) To record and temporarily hold the digital asset(s) listed on an electronic database, which is at all times in the possession and under the direct control of the Client or Service Provider;
 - b) To reproduce the digital asset(s) once, and only in the format and on the platform/publication described;
 - c) For the territories and time period specified until the expiry of the Licence or the program specified is completed, whichever occurs soonest and in accordance with the Terms and Conditions of the Agreement;
 - d) On the understanding that this Agreement is personal to the Client and that neither the licence nor any rights and permissions granted under it may be assigned, transferred, sub-licensed or charged to third parties without the prior written consent of National Museums Scotland.
- 2. This Licence is granted subject to the following conditions:
 - a) No reuse or further reproduction of the digital asset(s) whether for future programs or otherwise is permitted, except upon approval of a further application and payment in advance of any additional fees due;
 - b) No copy of the digital asset(s) shall be displayed on the world wide web at a lesser resolution than supplied;
 - c) The Client shall encrypt the digitised asset(s) using and agreed encryption code or watermark unique to the product, where possible;
 - e) The Client shall ensure that all displays/publication of the digital asset shall be accompanied by:
 - i) a copyright notice prohibiting any form of reproduction, transmission, performance, display, rental, lending or storage in any retrieval system without the written consent of the copyright holders;
 - ii) the credit line '© National Museums Scotland'; and /or
 - iii) a hyper link to the website of National Museums Scotland http://www.nms.ac.uk;
 - iv) a notice that downloading of digital assets for use by third parties and end users is strictly prohibited, except for private study. Downloading of digital assets for commercial purposes will be treated as a serious breach of copyright and strong legal action will be taken by National Museums Scotland. Evidence of anti-piracy measures taken by the Client may be required;
 - f) Evidence of display/publication to be shown to National Museums Scotland once live.
 - g) On completion of the licence period, all copies or records of the digital asset(s) made under this Licence shall be erased from the Client's database and confirmation of this provided to National Museums Scotland, unless a further licence is agreed and the relevant additional fees paid;
 - h) No adaptation, alteration or manipulation whatsoever of any digital asset either by the Client or a third party end user is permitted without the prior written consent of National Museums Scotland unless agreed under the terms of the licence;
 - i) The Client shall ensure that any third parties involved, including the distributors, are bound by the terms of the Licence;
 - j) The Client shall inform National Museums Scotland of any unauthorised use of any of their digital assets as soon as it becomes aware of the same.
- 3. In consideration of this Licence, the Client shall pay National Museums Scotland the Licence Fee and any Royalties due. The Licence Fee and Royalties apply to this Licence only. The Licence Fee is payable prior to delivery of the digital asset(s) to the Client. Where Royalties are due, the Client shall provide a quarterly account of the amount due in respect of the previous quarter's sales. The Client shall pay the due amount within 30 days of National Museums Scotland's invoice issue date. The Licence Fee and Royalties do not include digital asset supply, which is charged separately.
- 4. The Licence is at all times conditional upon full compliance with the Terms of this Agreement and may be revoked at any time if the Client is in breach of any of those Conditions. In any disagreement, the express terms of this Agreement shall prevail and any reproduction or use of any digital asset outside the scope or in breach of any of these said Terms and Conditions, shall be deemed unlicensed and an infringement of the Rights of National Museums Scotland.
- 5. This Licence shall be governed by the Laws of Scotland and the parties hereby agree to submit to the jurisdiction of the Scottish Courts.
